Dear Prospective Exhibitor,

Welcome to the 2021 season. It appears that things will be back in swing for the 2021 season! Attached please find an application form and an information sheet due by May 1, 2021.

The Bluemont Fair is a village-wide, two-day long country fair with an estimated attendance of between 7,500-10,000 visitors.

Exhibitors with fiber related items for sale, demonstrations and exhibition fiber livestock (i.e. sheep, goats, alpacas, llamas etc.) are located on the lawn of the Englund family (formerly Mitchell's lawn). For those who bring animals or hold demonstrations, the fee is \$85.00 per space. For those who do not, the fee is \$100. Spaces are limited and all are outdoors. You must provide your own shelter/canopy. No trailers are allowed and parking is prohibited. Designated vendor parking area is across the street. You will be able to unload your vehicle on Friday or Saturday morning, but you must move your car before the fair starts on Saturday morning.

The Bluemont Fair is widely advertised in local, county, state and regional venues, on community information sign boards and posters, on our website, in newspapers, in local libraries, in local community centers, in nearby retail stores and malls and in brochures at tourism locations.

DATE & TIME: September 18 and 19, 2021, 10:00 a.m. – 5:00 p.m.

SPACES: Outdoor space – 10' x 10' each. Cost \$85.00 per space (non-refundable) for those that bring animals or demonstrate a craft, \$100 for those who do not. Exhibitors will furnish their own table/chair/canopy.

ADVERTISING: Generic fair advertising is included in your vendor fee.

SECURITY: The grounds will be patrolled periodically Friday and Saturday night, however, all exhibitors will be responsible for their own material.

**STANDARDS:** All applicants that have not participated in Bluemont Fiber Fest previously are to submit at least four (4) 3" x 5" photographs displaying their exhibit and samples of items intended for sale.

Please label each photograph with your name and a brief description of the process and materials used to make the items. Photographs will NOT be returned. Digital photographs can also be e-mailed to [bbridget@comcast.net](mailto:bbridget@comcast.net). We ask that your fiber related items are of the highest quality workmanship, originality, and creativity, and prefer that they are hand made. All natural materials should be used whenever possible. A committee will evaluate all applications to determine their eligibility. The Bluemont Fair committee reserves the right to ask vendors who have misrepresented their merchandise to leave the show and forfeit all fees.

**DEADLINE:** All applications, with payment, should be received by May 1, 2021. (Jurying occurs during the month of May, and new applicants will be notified.)

**PAYMENT:** Payment may be made in the form of a check or money order made payable to the BLUEMONT FAIR, and mailed to Bluemont Fair's Fiber Field, P.O. Box 217, Bluemont, VA 20135.

**Applications submitted AFTER May 1, 2021 must pay a late fee of \$20.00 and will be accepted on a 'space available' basis.**

**APPROVAL:** Jurying of most new vendors occurs during the month of May. New artisans will be notified immediately following the jurying process by e-mail. Returning vendors, you will be notified by e-mail of the status of your application within 10 days of our receipt of your payment and application.

**CONFIRMATION:** You will be notified by e-mail, June 1, 2021 identifying your space number and a diagram of your space will be included.

**WELCOME PACKAGE:** A welcome package including exhibitors pins, parking tags, village layout map and general information will be handed to you upon arrival on Friday evening or Saturday morning.

**SALES TAX:** All vendors are required to collect and pay Virginia State Sales Tax of 6% on all merchandise sold. Contact the Commonwealth of Virginia Department of Taxation, P.O. Box 1103, Richmond, VA 23208.

**PARKING:** Parking will be across the street behind Stone's Field. Livestock trailers will be accommodated if possible. Additional parking for vendors is available in the general fair parking area. **ALL VEHICLES UNLOADING AND SETTING UP MUST BE GONE BY 9:00 AM SATURDAY AND SUNDAY MORNINGS.**

YOU ARE REMINDED THAT A NO-SHOW AT THE FAIR WILL RESULT IN REMOVAL OF YOUR NAME FOR FUTURE FAIR SOLICITATION.
